FEDERAL BUREAU OF INVESTIGATION

KEVIN WILLIAM MCCARTHY, white male, DOB 6/26/77 was interviewed at the U.S. Attorney's office. MCCARTHY was familiar with the identity of the interviewing agents and the nature of the interview. He then provided the following information:

MCCARTHY has previously provided information to the Philadelphia Division concerning his whereabouts on April 19, 1995. This information was reported in an FD-302 by Philadelphia.

MCCARTHY was then asked about his relationship with ANDREAS STRASSMEIR (phonetic). STRASSMEIR was described as a white male, late 30's, german, lived at Elohim City, Oklahoma for at least three years and was introduced to Elohim City by KIRK LYONS. LYONS is an attorney that represents white supremacists type individuals. MCCARTHY lived at Elohim City with STRASSMEIR at one time. SCOTT STEDEFORD and MICHAEL BRESCIA also lived with STRASSMEIR at one time. MCCARTHY believed that BRESCIA lived with STRASSMEIR for approximately one year. During STRASSMEIR's stay at Elohim City, he stayed at several different locations. STRASSMEIR was very knowledge about weapons. MCCARTHY added that he liked STRASSMEIR and that he had considered approaching him about joining the ARYAN REPUBLICAN ARMY to assist them in robbing banks; however he did not feel that STRASSMEIR would be accepting of the group.

MCCARTHY described Elohim City as a community that follows the Christian Identity movement. ROBERT MILLAR is the founder and the leader of the community which has approximately 100 residents. The people that live at Elohim City work in various types of businesses that are run by the sons of MILLAR. There is a shooting range at Elohim City and many of the people hunt.

MCCARTHY believed that many of the people that lived Elohim City left the community because the community was not radical enough toward the white supremacist movement. Many of the radical white supremacists stayed away from Elohim City because the MILLAR's were friendly towards JAMES ELLISON.

ELLISON was a member of The Covenant, Sword and the Arm of the Lord (CSA) and later became a government witness in the sedition trial against CSA.

MCCARTHY was first brought to Elohim City by MARK THOMAS, a Christian Identity preacher from Macungie, PA. THOMAS took MCCARTHY and his two sons, NATHAN and JOSH THOMAS to Elohim City when MCCARTHY was approximately fifteen years old. THOMAS was friends with ROBERT MILLAR who is approximately 70 years old. MILLAR has approximately ten kids. DAVID MILLAR is the owner of a construction company, BRUCE MILLAR owned a trucking company with approximately 19 semi-trucks and ZARAH PATTERSON runs a sawmill located at Elohim City.

MCCARTHY advised that he has never heard the name ROBERT or BOB JACQUES. In addition he did not become aware of the names MCVEIGH, NICHOLS, FORTIER or COBURN until after the Oklahoma City bombing.

MCCARTHY recalled that a USA Today newspaper was left on the seat of one of the getaway vehicles by SCOTT STEDEFORD to taunt law enforcement. Also they purchased a getaway vehicle in the name of WAYNE MANIS to taunt law enforcement.

MCCARTHY was then asked about some information that was learned from RICHARD GUTHRIE at the time of his debriefing. MCCARTHY advised that STEDEFORD associated with a skinhead band called "BOUND FOR GLORY" that was from the Minneapolis, MN area. MCCARTHY had never been to this area. MCCARTHY recalled that many people would bring weapons to Elohim City to sell. He believed that this was done because people knew that the community was interested in firearms. MCCARTHY had purchased a Glock .45 caliber pistol and a copy of Smith & Wesson Model 1911, .45 caliber pistol at Elohim City. MCCARTHY was not familiar with any of these firearms being stolen.

MCCARTHY has never heard the name ROGER MOORE.
